**PLEASE TAKE NOTICE** that on the 30th day of June, 2009, at 1:00 p.m., or as soon thereafter as counsel may be heard, the undersigned, attorneys to St. Mary's Hospital, Passaic, N.J., the debtor and debtor-in-possession herein ("St. Mary's", "SMH" or the "Debtor"), shall move before the Honorable Morris Stern, United States Bankruptcy Judge, at the United States Bankruptcy Court, Martin Luther King, Jr. Federal Building, 50 Walnut Street, Third Floor, Newark, New Jersey 07102, for an Order Pursuant to Section 1121(d) of the Bankruptcy Code Extending Debtor's Exclusive Periods Within Which to File a Chapter 11 Plan and Solicit Acceptances Thereto (the "Motion").

**PLEASE TAKE FURTHER NOTICE** that in support of the Motion, the Debtor will rely upon the Application submitted herewith.

**PLEASE TAKE FURTHER NOTICE** that objections, if any, to the relief requested in the Motion shall: (i) be in writing, (ii) state with particularity the basis of the objection; and (iii) be filed with the Clerk of the United States Bankruptcy Court in accordance with the Order Establishing Certain Notice, Case Management, and Administrative Procedures dated June 2, 2009 and Notice, Case Management, and Administrative Procedures annexed thereto as Exhibit 1 (collectively "Case Management Order") no later than Monday, June 29, 2009 at 5:00 p.m., and shall be served in accordance with the Case Management Order no later than Monday, June 29, 2009 at 5:00 p.m.

**PLEASE TAKE FURTHER NOTICE** that a proposed order incorporating the relief sought is submitted herewith.

**PLEASE TAKE FURTHER NOTICE** that unless objections are timely presented, the Motion shall be deemed uncontested in accordance with L.B.R. 9013-1(a) and the requested relief may be granted without a hearing.

**PLEASE TAKE FURTHER NOTICE** that the undersigned requests oral argument on the return date of the Motion if objections are timely presented.
